## Medicaid

Medicaid offers health care coverage for children, pregnant women, people with disabilities, people 65 and older, and some adults caring for children. It helps with bills for doctors, hospitals, nursing homes and prescriptions ordered by a doctor. Children who get Medicaid will also be in the Texas Health Steps program.

## CHIP Perinatal Coverage

The CHIP perinatal coverage offers prenatal care to pregnant women who cannot get Medicaid and do not have other health coverage. Benefits may include up to 20 prenatal visits, prescriptions ordered by a doctor, costs of giving birth, two doctor visits for the mom after the baby is born, and regular checkups, vaccines and prescriptions ordered by a doctor for the baby.

## Children's Health Insurance Program (CHIP)

CHIP is for children ages 18 and younger. It is an insurance program for families who earn too much money to get Medicaid but cannot pay for private insurance.

## Supplemental Nutrition Assistance Program (SNAP)

SNAP helps families buy food. SNAP benefits are given through the Lone Star Card. This is a plastic card that is used like a debit card.

## Temporary Assistance for Needy Families (TANF)

TANF helps families with children ages 18 and younger pay for things like food, clothing and housing. TANF benefits are given through the Lone Star Card. This is a plastic card that is used like a debit card. Learn more at [YourTexasBenefits.com](https://YourTexasBenefits.com).

## Healthy Texas Women

This program offers women's health and family planning services at no cost to eligible women in Texas. WIC clients already meet the income eligibility requirements for Healthy Texas Women. Services include pregnancy testing, birth control methods, tests for breast and cervical cancers, screening and treatment for sexually transmitted infections, postpartum depression, cholesterol, diabetes, high blood pressure and more.

Healthy Texas Women also offers clients additional postpartum services that focus on major health conditions like mental health, heart disease and substance use disorders. For more information, visit [HealthyTexasWomen.org](https://HealthyTexasWomen.org).

Family planning clinics offer pregnancy testing, birth control methods, tests for breast and cervical cancers and HIV testing and counseling. This program also offers screening for diabetes, cholesterol, high blood pressure, sexually transmitted infections and treatment. All services are kept private.
